Parade Rules & Regulations

- 1. Entries must observe all rules and regulations. The Oxnard Downtowners Christmas Parade Committee reserves the right to remove any entrant not conforming to these rules and regulations, or any entrant refusing to follow instructions of police, parade officials or state laws.
- All entries must check-in by assigned time. Late arrivals will be admitted only at the discretion of the committee. No one will be allowed to 2. enter the parade after it has started. No one will get on or off a float or entry once it has started down the parade route.
- Do not park cars or other vehicles in the staging area that are not part of your entry. 3.
- All entries must be decorated and are encouraged to follow the theme. Un-decorated entries are not allowed. 4.
- 5. There must be an adult on floats where there are children. All floats shall have handrails at perimeter when there are riders.
- No Santa Claus suits allowed. Santa will be the last entry in the parade. 6.
- 7. Throwing of candy or objects from floats or vehicles is not allowed. Handing out candy or objects to the crowd is permitted by walkers only.
- Jumping or scraping of vehicles is NOT allowed at any time during the parade. Violation will result in immediate removal from the parade. 8.
- Maximum allowable height for floats and vehicles is 14 feet. 9.
- 10. Stopping for performance is allowed only at the ONE judging stand location at Plaza Park. Limit your performance to one minute. Do NOT perform at announcer stations posted along the route.
- 11. All entries must ensure they are keeping pace with the entry ahead of them to ensure there are no unreasonable gaps interrupting the parade flow.
- 12. Owners of parade vehicles shall ensure that all such vehicles are insured as required by California law.
- 13. No loaded firearms at any time.
- 14. NO SMOKING OR ALCOHOLIC BEVERAGES ON ANY PARADE ENTRY AT ANY TIME BEFORE OR DURING THE PARADE! SAFETY COMES FIRST!!!
- 15. Parade entries violating any of these rules, may be denied entry in future parades.
